**Proceedings for July 13**

**Chairman's Report**

**Council Appointments.** Mr. Armentano announced the appointment of three new members of the Council. **Code of Ethics and Conflict of Interest.** Mr. Armentano directed councilors' attention to the PERC Code of Ethics and Conflict of Interest at their tables and instructed them to

review the code and sign it. He noted that the code had been modified this year to more closely conform to codes that have been adopted by commodity checkoff programs approved by the U.S. secretary of agriculture.

Ms. Caskin summed up the training and safety initiatives in the 2012 business plan.

PERC Chief Information Officer Kay Howell described the information technology initiatives in the 2012 business plan.

Mr. Harris presented the proposed 2012 budget. Upon a motion duly made and seconded, the Council approved the publication of the 2012 budget plan for public comment.

Mr. Willis asked the Council to approve an amendment to the PERC Policies, Rules, and Procedures to make funding requests that exceed \$500,000 ineligible for the consent calendar. Upon a motion duly made and seconded, the amendment was approved, and PRP section 8.10. will now reads as follows:

**8.10. Council Discretion.** *Except as otherwise provided in this document, the Council shall decide, by majority vote, which projects shall be considered and/or funded and at what level. Each project of an amount exceeding \$500,000 shall be decided by a separate vote.*

Mr. Armentano announced that he had directed the president and CEO to ask for competitive bids on any ongoing contracts worth more than \$1 million.

**New Business**

Mr. Armentano directed councilors' attention to the 2012 Council meeting dates and locations.

Mr. Armentano announced that Council will next meet in Washington on October 13 and 14. He said the Executive Committee will meet on the morning of the October 13.
