

PERC Plumber/HVAC Train the Trainer Contest Official Rules

NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE CHANCE OF WINNING. Contest ends 05/31/2022.

ELIGIBILITY: The Contest is only open to instructors or trainers in the plumbing or heating, ventilation and air conditioning (HVAC) industries who are legal U.S. residents and 18 years of age or older (or 19 years of age or older for residents of AL and NE) as of January 1, 2022. All entrants must be willing to implement the Propane Education & Research Council (PERC) course, *HVAC and Plumber Technical Training*. Employees of the Sponsor, the Sponsor Affiliates or any of the members of their immediate family (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren) or same household of each are not eligible to participate. This Contest is void in Puerto Rico, Guam, the Virgin Islands, U.S. Territories and Possessions, and where prohibited or restricted by law, and is subject to all applicable federal, state and local laws.

HOW TO ENTER: Enter the Contest beginning at 12:00:01 AM ET 3/01/2022 and ending 11:59:59 PM ET 05/31/2022. Entrants must visit the website at www.propane.com and complete the online registration form including the reason why they want to attend the in-person training about the course. Entries must be received by 11:59:59 PM ET 03/01/2020 and must be complete in order to be eligible. Online entries generated by script, macro or other automated means are void. Normal internet access and usage charges imposed by entrant's online service will apply. Neither the Sponsor nor the Sponsor Affiliates assume any responsibility for incorrect or inaccurate capture of entry information, including, but not limited to, technical malfunctions, human or technical errors, printing errors, lost/delayed/garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software, or any combination thereof.

PRIZES AND APPROXIMATE VALUE: Eighty (80) Grand Prizes: Roundtrip airfare (if applicable) to the training location (Tampa ,FL) and one-night hotel stay for one individual in or near the training locations for the *HVAC and Plumber Technical Training* training session. Judging will be based on the entrants' statements regarding why they wish to attend the in-person training for the course. Additional communications between judges and entrants may take place during the judging period via phone or email. The contest judges will be executives from PERC. Contest judging will be held on or about 06/01/2022 and winners will be notified via telephone or email around 06/10/2022. Decisions of the judges are final and binding on all matters relating to this Contest. Odds of winning are dependent upon the number of eligible entries received. If any notifications are not responded to within one week, Sponsor reserves the right to withdraw the prize and award to an alternate winner. Limit one prize per person/family/household. Taxes are the sole responsibility of winner. Winner may be required to complete IRS Form W-9, an affidavit of eligibility and a publicity release form prior to receiving his or her prize.
